# **ALEXANDROS CHARKIOLAKIS**

University of Sheffield

Alexandros Charkiolakis is Director of the Friends of Music Society, responsible for its artistic, research and educational projects. He is also the President of the Board of the International Association of Music Libraries branch in Greece. Both in his current posts and previously, he has influenced students, the general public and the academic community through his extensive publications and work as a teacher, musicologist and conductor. His aspiration for his work in one of the key stakeholders in Greece's artistic life, which is based at the Athens Concert Hall, is that it will set a new strategic direction in projects that merge the worlds of music, technology and arts. Alexandros holds a Bachelor of Music in Music and a Master of Music by Research in Musicology and Conducting from the University of Sheffield. He believes that studying in the UK has equipped him with analytical thinking, scientific capacity and artistic empathy which have proven vital to his professional career.

He has extensive professional experience in national and international universities, professional associations and institutions, specialising in large investment appraisal and large projects financing. Dimitrios holds a Master of Science in Airport Planning and Management from Cranfield University. Taking advantage of his UK education and its international reputation in the aviation industry, Dimitrios is now a leader in the transport industry in Greece promoting his research outputs and top management experience in governmental bodies, institutions and international organisations such as the United Nations, the Organisation for Economic Co-operation and Development (OECD) and the International Civil Aviation Organisation (ICAO).

Dr Chryssanthi Papadopoulou is the Assistant Director of the British School at Athens. She has developed new methods of approaching the ancient world and its people, while her work has inspired more than half of her students to pursue postgraduate degrees in archaeology in the UK. Chryssanthi holds a Master of Science in Maritime Archaeology from the University of Southampton and a PhD in Classical Archaeology from King's College London. She was also an Erasmus student in Byzantine Studies at Queen's University Belfast. She feels that the UK has provided her with a solid theoretical grounding due to its being at the forefront of archaeological theory for more than four decades, and that her UK education has given her critical skills such as synthetic and independent thinking to produce high quality research.

She is a partner in Metavallon.vc and founder and director of Metavallon Ventures Limited. Alexandra's work has been instrumental in igniting the Greek technology start-up ecosystem and fuelling the market with able risk capital as a means towards business competitiveness in the global context. Alexandra has recently succeeded in securing a 32-million-euro venture capital fund from the European Investment Fund to invest in very early-stage Greece-related technology companies in the next four years, aiming to drive cuttingedge businesses beyond borders and towards international success and recognition. Currently he is collaborating with the Association of Greek Chemists, overseeing publications and communications, and delivering seminars and training courses in communication and public speaking around the world. His work has been recognised through awards and nominations for a range of prestigious science communication prizes such as his national nomination for the UNESCO Kalinga Prize, the first prize in the British Council's FameLab competition, his nomination twice for the Greek Science Writer of the Year by the Association of British Science Writers. He has spearheaded efforts for more science in Greek society for many years driven by his motto that 'a better society is a scientifically literate society.' Spiros believes that his UK education fuelled his passion for science and communication, it gave him inspiration for his scientific excellence and triggered his successful professional career in academia, communication and public speaking. Aggeliki Pappa is the Founder and CEO of 'i love dyslexia' (ILD), the first highly specialised organisation globally for Teaching English as a Foreign Language to students with dyslexia and learning differences holistically. She is also President of the non-profit organisation 3DlexiaCosmos, which connects thousands of students and teachers globally with the #SOS4LoveProject, cultivating education for sustainable development, presented at the United Nations and supported by the Ministry of Education and Culture in Cyprus. Aggeliki has been a life-long volunteer, training thousands of educators in Greek state schools and globally, making a difference in the field of EFL and dyslexia, building a powerful stigma-free voice in foreign language teaching, while supporting refugees' education. Her work has been recognised by prestigious organisations such as her national nomination for the UNESCO-Hamdan Prize, her distinction in 'Greece Innovates!' and in the Global Teacher Prize that included her in the list of the Top 50 Educators globally for two consecutive years (2016 and 2017). Aggeliki's studies in the UK were instrumental in the development of her educational 3DlexiaParadigm and life skills that led to her innovations. Aggeliki's vision for a sustainable world is guiding the expansion of her innovative educational and humanitarian actions to support millions of students and teachers globally. Aggeliki holds a Master of Education in Inclusion and Special Educational Needs from the University of Birmingham.
