## We process your data for the following purposes:

To carry out teaching activities which may include: using personal data (student image and voice) during the real time broadcasting of online classes through the British Council learning hub; using student photographs and audio or video recordings as academic support; connecting with British Council students from other countries, sharing their work and class recordings for the purposes of the course and to support academic training for British Council staff; connecting with British Council students from other cultures; use of the learning hub, including discussion forums and portfolios. Personal data collected and shared through and for the purpose of the learning activities described above will only be retained as long as necessary, for the purposes it was collected and for the duration of your relationship with us. Our lawful basis for all course-related administrative and teaching activities is the performance of a contract for the provision of our services. Consent can be withdrawn by contacting your local British Council Customer Service team.

To take into account special learning or health needs. The student, or the parent of a student under 18 years old, can provide on a totally voluntary basis, information about the medical condition of the student, that will allow us to take into account the specific learning needs of the student, or provide a better service, e.g. should dietary requirements need to be considered. We shall keep this information while the contractual relationship is in effect.

To gather customer feedback about contracted products; to send electronic marketing communications about similar British Council products, services and activities based on your consent. We shall keep data for these purposes while the data subject does not exercise their wish to object to such processing or requests to be unsubscribed from receiving promotional communications.

Consent for the collection and processing of the students photos and videos

#### What is the legitimate basis for our processing of your data

The course administration and teaching activities are legitimised by the performance of a contract for the provision of services in combination with Law 2251/1994 for the Consumers Protection as in force and codified by the Ministerial Decision No 5338/2018. Not providing any of the requested personal data may affect the timely delivery of the services with the required

accuracy and efficiency. Processing information about special educational needs and specific health requirements so that we can deliver a better targeted service is legitimised by the specific consent of the student, or their parent if the student is under 18 years old. Communications to the client related with the contracted course are legitimised by the performance of a contract. Our clients include: adult students; parents of young learner students; employers of adult students granting professional development to their employees.

Customer feedback and marketing communications on similar products and services are legitimised by the performance of a contract and the exemption allowed in article 11 of Law 3471/2006, as currently in force.

## Your rights over our processing of your personal data:
